

SUMMER PHOTO CHALLENGE COMPETITION RULES

ARTICLE 1

Brussels Airport Company NV/SA, with its registered offices at 1030 Brussels, Auguste Reyerslaan 80, with enterprise number 0890.082.292 ('Brussels Airport Company' of 'BAC'), is organising a competition without purchase obligation, which will start on 24/06/2022 and end on 10/09/2022 included.

ARTICLE 2

Participation in this competition is open to all individuals who have a public social media account.

By entering the competition, participants will be deemed to have accepted these competition rules without any reservation. No disputes will be accepted regarding the choice of the winner(s).

Minors may only participate in online competition with the express permission of one of their parents or their guardian. Brussels Airport Company will assume that any minor entering a competition is doing so with the permission of their parents or guardian. Minors who are unable to provide confirmation of this permission may at any time be denied further participation in the competition or have their right to a prize taken away.

ARTICLE 3

In order for any entry into the competition to be valid, participants must take one or more photos at one of the summer decorations at Brussels Airport. These photo(s) need to be shared on 1 or more social media channels with #brusselsairport. Make sure your profile is public. An independent jury within Brussels Airport Company will select 3 winners out of all the publicly shared photos with #brusselsairport based on original and creative effort. The selection will take place on 14 September 2022.

All incomplete entries will be excluded from the competition. All participants are restricted to a maximum of one entry in the competition per social media account.

Participants of this contest who are member of the Enjoy! Brussels Airport Rewards Programme, to be found on <https://enjoy.brusselsairport.be/nl/>, can participate in the second part of this contest. The participant who fills in his Instagram account username with which he took part in the above mentioned conditions and approaches the question best, wins one travel voucher worth € 1,000. Any entry that is incomplete will be excluded from participation. Each participant may take part in the competition no more than once.

ARTICLE 4

Participants in the competition will have a chance of winning 1 out of 3 travel vouchers worth € 1,000 and 1 travel voucher worth € 1,000 through the Enjoy! Brussels Airport Rewards Programme.

ARTICLE 5

The winner will receive a personal confirmation via (private) message on used social media channel. Prizes are not exchangeable, have no cash value, either in full or in part, and cannot be transferred to a third party. BAC reserves the right to provide a prize equivalent in value to the stipulated prize.

ARTICLE 6

With the exception of the scenario provided for in Article 5, there will be no electronic communication or communication by telephone with regard to this competition, nor will any letters be

sent, either while the competition is ongoing or after it has concluded.

ARTICLE 7

Only one prize will be awarded per social media account.

The penalty for any attempt to commit fraud or artificially improve the chance of winning and any form of manipulation, irrespective of whether this is done in an organised manner and irrespective of whether this is done by means of a computer program, will be the immediate exclusion of the participant.

ARTICLE 8

BAC will at all times have the right to exclude a person from participation in competitions organised by BAC for a specific period of time, in the event of a breach of one of the participation conditions or in the event of abuse, deception or entry into a competition in bad faith.

ARTICLE 9
