

## APRÈS-SKY DJ CONTEST RULES

---

### ARTICLE 1

Brussels Airport Company NV/SA, with registered office at BluePoint Brussels, Boulevard Auguste Reyerslaan 80, 1030 Brussels, Belgium, with company number 0890.082.292 (RPR/RPM Brussels) and with place of business at Brussels National Airport 1M, Compass Building, 1930 Zaventem, Belgium ('BAC'), is organising a contest without purchase obligation, which will start on 10/11/2023 and end on 26/11/2023.

### ARTICLE 2

Participation in this contest is open to all individuals with DJing skills and the willingness to come perform at Brussels Airport in the given period, mostly using après-ski music. Participation in this contest implies agreement with the contest rules.

### ARTICLE 3

To validly participate in the competition, one must

1. Share a video publicly on social media where the contestant is visibly the DJ and creating the music.
2. The allowed social media channels are Instagram, Facebook and Youtube.
3. All or part of the music in this video must be in the "après-ski" genre.
4. In the publicly shared post, Brussels Airport must be tagged via @brusselsairport.
5. The participant sends an e-mail to [passenger.experience@brusselsairport.be](mailto:passenger.experience@brusselsairport.be) stating
  - o a link to the post on Social Media
  - o first and last name
  - o cell phone number
  - o a photo for promotional purposes
  - o artist name, if any

Any entry that is incomplete will be excluded from participation. Each participant may enter the contest a maximum of one time.

### ARTICLE 4

A maximum of 10 winners may be designated.

The winner(s) will be chosen as follows: the participating videos will be viewed by a randomly selected jury, which will choose a set of winners via voting.

The winner(s) will be personally notified by email.

### ARTICLE 5

The winner(s) of the contest will win the following prizes:

- voucher of €25 at Autogrill
- voucher of €50 at Lagardère
- the opportunity to play 2 hours of music at Brussels Airport on the corresponding day in front of the airport audience
- Publicity on the social media channels of Brussels Airport

Prizes are non-exchangeable, non-cash, and non-transferable to third parties. BAC reserves the right to give a prize whose value is equal to the anticipated prize.

Only one prize can be awarded per (e-mail) address, per family and per IP address.

### ARTICLE 6

BAC may at any time exclude a person from participation in this contest or any other (future) contests, in case of breach of any of the conditions of participation or in case of (suspected) abuse, fraud or bad faith participation in a contest.

### ARTICLE 7

BAC reserves the right to change the competition or its course in case of unforeseen circumstances or if circumstances beyond BAC's control justify it. BAC cannot be held liable if, due to circumstances beyond its control, the match should be interrupted, postponed or cancelled.

### ARTICLE 8

BAC reserves the right to communicate about the competition and its winners, e.g. for promotional purposes.

By participating, participants agree that if they win a prize, they may appear on BAC's social media, website and other digital or analogue channels with photo, name and place of residence, if applicable.

### ARTICLE 9

BAC is not liable for any possible damages, physical injuries or accidents that may occur as a result of winning a prize and/or participating in a competition.

BAC is not liable for printing, spelling, typesetting or other errors or technical problems (relating to the Internet, e-mail, etc.).

### ARTICLE 10

The participant expressly consents to the processing of the following personal data by BAC [First and last name, mobile phone number, artist name, e-mail address, social media profiles] to ensure the handling of this competition.

If the participant has expressly agreed to this by ticking the box provided for this purpose, BAC may inform this participant regarding promotions, offers and competitions, including via its newsletters.

BAC handles personal data in accordance with the applicable regulations.
