

## BELGIAN TREASURES PHOTO CHALLENGE COMPETITION RULES

### ARTICLE 1

Brussels Airport Company NV/SA, with registered office at 1030 Brussels, Auguste Reyerslaan 80, with company number 0890.082.292 ('Brussels Airport Company' or 'BAC') is organising a competition with no obligation to buy, running from 05/09/2023 until 15/11/2023.

### ARTICLE 2

Participation in this contest is open to any person who has a public social media account.

Participation in the competition implies acceptance of these competition rules without any reservation. No dispute will be accepted regarding choice of winner(s).

Minors may only participate if they have the express permission of one of their parents or guardians. If a minor takes part in the competition, Brussels Airport Company assumes that he/she has the permission of his/her parents/guardian. If the minor cannot produce this consent, he/she may be denied further participation in the competition at any time, or his/her right to a prize may be taken away.

### ARTICLE 3

To validly enter the competition, one must take 1 or more photos at 1 of the Belgian Treasures decorations at Brussels Airport. This photo(s) should be shared on 1 or more social media channels with @brusselsairport. Make sure your profile is public. An independent jury within Brussels Airport Company will select winners based on original and creative effort from all publicly shared photos with @brusselsairport. Three winners will receive a travel voucher worth €500; 25 winners will receive a ticket to the Magritte Museum in Brussels. Selection will continue 20 November 2023. Any entry that is incomplete will be excluded from participation. Each participant may enter the competition a maximum of once per social media account.

### ARTICLE 4

Contest entrants will have a chance to win 1 of 3 travel vouchers worth €500 or 1 of the 25 tickets to the Magritte Museum in Brussels.

### ARTICLE 5

Winners will be notified personally via a (private) message on their used social media channel.

Prizes cannot be exchanged and are not convertible into cash, in whole or in part, and are not transferable to third parties. BAC reserves the right to give a prize whose value equals the provided prize.

### ARTICLE 6

Except for the case provided for in Article 5, there will be no telephone or digital communication concerning this competition, nor will any correspondence be sent, either during the competition or after its conclusion.

### ARTICLE 7

Only one prize will be awarded per social media account.

Any attempt at fraud and any attempt to artificially increase the chances of winning or any form of manipulation, whether organised or not and whether subject to the use of an IT programme, will be punished by immediate exclusion of the participant.

### ARTICLE 8

BAC may at any time exclude a person from participating in competitions organised by BAC for a certain period, in case of breach of any of the conditions of participation or in case of abuse, deception or bad faith participation in a competition.

### ARTICLE 9

The organisers of this competition reserve the right to change the action and the competition or its course in the event of unforeseen circumstances or if circumstances beyond the organisers' control justify it. They cannot be held liable if, due to circumstances beyond their control, the competition should be interrupted, postponed, or cancelled.

### ARTICLE 10

BAC reserves the right to communicate about the competition and its winners, including for promotional purposes.

By participating, participants agree that if they win a prize, they may appear on BAC's social media, website and other digital or analogue channels with their photo, name, and hometown, if applicable.

### ARTICLE 11

BAC is not liable for any possible damages, physical injuries or accidents that might occur because of winning a prize and/or participating in a competition.

BAC is not liable for printing, spelling, typesetting or other errors or technical problems (related to internet, e-mail, ...).

### ARTICLE 12

The participant expressly consents to the processing of the following personal data by Brussels Airport Company (social media profile, name, address, email address, preferred language) to ensure the processing of this competition.

BAC handles personal data in accordance with the relevant regulations.
