

## CONTEST RULES – OLYMPIC GAMES PHOTO CONTEST

date: 15/01/2026

---

### ARTICLE 1

Brussels Airport Company NV, with registered office at Priester Cuypersstraat 3, 1040 Etterbeek, enterprise number 0890.082.292 (RPR Brussels), and with operating office at Brussels National Airport 1M, Compass Building, 1930 Zaventem ("BAC"), is organizing a contest with no purchase obligation, running from 15/01/2026 until 15/03/2026.

---

### ARTICLE 2

Participation in this contest is open to any person aged 18 or older, with the exception of: employees of BAC and its partners, its advertising agencies, and any other person who contributed to the creation of this contest.

Also excluded from participation are: first-degree family members of the persons mentioned above, as well as persons residing at the same address as the individuals mentioned in the previous paragraph.

Participation in the contest implies acceptance of these contest rules.

Persons under 18 may participate only if they have the explicit consent of one parent or guardian. If a person younger than 18 participates, BAC assumes that he/she has parental or guardian consent. If the participant cannot provide this consent, their participation may be denied at any time, or their right to a prize may be withdrawn.

### ARTICLE 3

To validly participate in the contest, one must fully complete the questionnaire together with a photo taken at one of our designated photo booths at Brussels Airport.

Any incomplete participation will be excluded.

### ARTICLE 4

A maximum of three (3) winners may be designated.

The winners will be chosen by a team from Brussels Airport.

The winners will be personally notified by email. If they fail to respond within 14 calendar days of this notification, BAC reserves the right to withdraw the prize and designate another winner.

### ARTICLE 5

The winner(s) of the contest will receive the following prize(s): a travel voucher worth €500.

Prizes cannot be exchanged, converted into cash, or transferred to third parties. BAC reserves the right to award a prize of equal value.

---

### ARTICLE 6

Each person may participate only once in the contest. The same person may not participate with different email addresses. Additionally, only one prize can be awarded per person, per email address, and per IP address. The same individual may win the first prize only once per calendar year in any of the online contests organized by BAC.

---

### ARTICLE 7

BAC may exclude any person from this contest or any other (future) contests at any time in case of violation of one of the participation conditions, or in case of (suspected) abuse, fraud, or bad-faith participation. BAC may also do so if a designated winner does not respond to the notification described in Article 4.

---

### ARTICLE 8

BAC reserves the right to modify the contest or its course in case of unforeseen circumstances or circumstances beyond BAC's control that justify such action. BAC cannot be held liable if the contest must be interrupted, postponed, or canceled due to circumstances beyond its control.

---

### ARTICLE 9

BAC reserves the right to communicate about the contest, e.g., for promotional purposes.

---

### ARTICLE 10

BAC is not liable for any possible damage, physical injuries, or accidents that may occur as a result of winning a prize and/or participating in the contest.

BAC is not liable for printing, game, typographical, or other errors, or for technical problems (related to internet, email, etc.).

### ARTICLE 11

The participant explicitly consents to the processing by BAC of the following personal data: name, address, email address, preferred language, and personal photo, in order to ensure the handling of this contest. These data will be stored for 30 days from the final participation date to ensure correct processing of the contest.

If the participant explicitly agrees by ticking the appropriate box, BAC may inform this participant about promotions, offers, and contests, e.g., via newsletters.
